# NOTICE OF RACE

The FINN World Master 2005 will be held from 13<sup>th</sup> to 20<sup>th</sup> May 2005, at Bracciano Lake - Rome (Italy), organised by the Club Amici Velici Vigna di Valle, with the collaboration of Centro Sportivo Aeronautica Militare - Sezione Velica di Vigna di Valle, Ali6 Club Vela, Circolo Velico Tiberino, Associazione Sportiva Nautica Sabazia, the International Finn Master Association and the National Finn Association.

### 1. RULES

The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2005-2008 (RRS) . The Italian Sailing Federation (FIV) prescriptions will apply and will be stated in full in the Sailing Instruction. Of these, those that may require advance preparation are stated in full in the present Notice of Race. Should a conflict between the Notice of Race and the Sailing Instructions exist, the Sailing Instructions will prevail. If there is a conflict between different languages, the English text will take precedence.

#### 2. ADVERTISING

Competitors may display individual advertising according to the ISAF Regulation 20 for events classified within the Category C. Competitors may be required to display advertising in accordance to the ISAF Regulation 20.3 (d) (i).

#### 3.ELIGIBILITY

The regatta is open to all boats of the Finn class with a valid measurement certificate, for helmsmen born in 1965 and before, in accordance with the Finn Master Association rules.

All competitors must comply with the eligibility requirements established in the ISAF Regulation 19 and the Class Rules. The FIV Prescription at RRS Rule 69.3 states: "Automatically and without any procedure, all competitors suspended by any National Authority or ISAF shall not engage in any competition in Italy during the entire suspension period".

## 4. ENTRIES

Eligible boats must register by completing the form on the Finn Master Class web site (www.finnworld-master.com) or by sending via fax the attached form to 0049 1212 583620410 before the 30<sup>th</sup> April 2005. Entries received after the 30<sup>th</sup> April 2005 will be accepted only after the approval of the Organisation Committee.

The entry fee of 130,00 Euro (non refundable) should be paid in cash to the Race Office of Club Amici Velici Vigna di Valle, within the  $15^{th}$  may 2005.

Other fees:

- Staying at the Club field with a camper or a tent:	€ 15,00
for each camper or tent, power provisioning not included.	
- Social dinner and cocktails, for each non competitor:	€ 30,00
(children below 12 y.o. for free)	

# 5. REGISTRATION OF COMPETITORS

Each competitor shall personally fill out and sign the entry form at the Race Office of Club Amici Velici Vigna di Valle between 13<sup>th</sup> and 15<sup>th</sup> May (10 am - 7 pm). At registration each competitor must provide and deliver the following documents to the Race Office:

a) A valid Measurement Certificate;

b) A valid third party liability insurance with a minimum cover of Euro 1.036.000,00 or equivalent, per event for material damage or personal injury or death, according to the FIV Prescription at RRS Rule 68.

c) Italian competitors, the FIV 2005 license with the health certification.

# 6. SCHEDULE

The event will be scheduled as follows:

-	Registrations and sailing instructions hand over:	13 <sup>th</sup> - 15 <sup>th</sup> May from 10 am to 7 pm
-	Measurements:	13 <sup>th</sup> - 15 <sup>th</sup> May from 10 am to 7 pm
-	Practice race:	15 <sup>th</sup> May, 1 pm
-	Open ceremony:	15 <sup>th</sup> May, 6 pm
-	Races:	16 <sup>th</sup> to 20 <sup>th</sup> May
-	Social dinner:	18 <sup>th</sup> May
-	Prize giving ceremony:	20 <sup>th</sup> May

The scheduled time of the warning signal for the practice race is 1 pm; the scheduled time of the warning signal for the first race is 1 pm; the warning signal for the other races will be notified before 7 pm of the day before the race.

A maximum of six races, with no more than two races per day, will be sailed.

# 7. MEASUREMENT AND INSPECTION

Each boat shall produce a valid measurement certificate; as prescribed by class rules any boat shall have a painter, minimum diameter 8 mm and minimum length 8 meters, capable of floating on board. Measurement will be taken as described in the schedule paragraph. In addition, controls may be undertaken at any moment ashore or at sea.

#### 8. COURSES

Courses will be windward/leeward or triangle or trapeze, depending on weather conditions and at uncensorable decision of the Race Committee.

### 9. SCORING

The "Low Point Scoring System" described in RRS Appendix A 4.1 will apply.

A minimum of three races are required to be completed to constitute a series for Championship validity. When four or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## 10. INTERNATIONAL JURY

The composition of Race Committee and International Jury will be notified by exposing a notice on the Official Notice Board. The International Jury will be appointed in accordance with RRS Appendix N; its decisions will be final as provided in RRS rule 70.4.

## 11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS rule 4, "Decision to Race". The organizing authority or any part involved with the organisation of the event will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 12. PRIZES

Prizes will be given to the top three competitors over-all and to the top three competitors in each of the following category: Master from 40 to 49 years old, Senior, from 50 to 59 years old, Grand Master from 60 years old.
