ORGANIZER: The Organizing Authority is SK Kaparen and SS Vikingarna, in conjunction with the Swedish Finn Association and Swedish Sailing Federation (MNA) on behalf of the International Finn Association. The Regatta Centre will be in Kalmar habour.

1. RULES.

- **1.1.** The event will be governed by the 'rules' as defined in the Racing Rules of Sailing for 2005-2008 (RRS), execept as any of these are altered by this Notice of Race or the Sailing Instructions. The Finn Class Rules will apply.
- **1.2.** All boats may in accordance with ISAF Regulation 20 display advertising provided by the event organiser.
- **1.3.** All boats shall display a bow number on both sides of the forward 10% of the hull. The bow numbers as well the advertising will be available by the Organising Authority and can be collected at the Regatta Office.

2. Advertising

Advertising will be restricted to Category C.

3. ELIGIBILITY REQUIREMENT AND ENTRY.

- **3.1.** The person in charge onboard the boat shall be a member of his/her Member National Authority or one of its affiliated organisations.
- **3.2.** Only competitors eligible in accordance with Finn Class Rules, who are current members of an IFA, recognized Nation Finn Association and who have completed registration on-site prior to 2005-08-08 may compete.
- **3.3.** A competitor shall not be under suspension of ISAF eligibility.
- **3.4.** The entry quota of Part D " Entry System for IFA Official Championships" of the Finn Class Rules will apply. Entries must be submitted on the official website, <u>www.eurofinn2005.org</u> or through the National Finn Secretaries on the Official Entry Form no later than 2005-07-02 to SK Kaparen C/o Patrik Schander, Kungsgårdsvägen 24 A, 393 53 Kalmar, Sweden.
- **3.5.** No entry is complete untill the Organizing Autority and the International Finn Association have accepted it.

8. EQUIPMENT AND MEASUREMENT CHECKS.

- **8.1.** Measurement certificate must be presented at on-site registration.
- **8.2.** All competitors shall hold a valid measurement and class registration certificate. Measurement certificate shall be presented prior to racing.
- **8.3.** A boat or equipment may be inspected/measured at any time during the Championship for compliance with the class rules and sailing instructions.

- 8.4. All boats shall undergo measurement of hulls, spars and sails as well as equipment checks according the Finn Class Rules (including item 10 of Part C " Major Championship Rules") unless otherwise decided by the IFA Cheif Measurer. All measured equipment will be identified for the Championship. Only identified equipment may be used during the Championship.
- **8.5.** Each boat shall have a tow rope a minimum of 8 meters in length and of sufficient strength to tow several boats.

9. SAILING INSTRUCTIONS.

The sailing instructions will be handed out upon completion of the registration.

10. VENUE.

- **10.1.** The regatta office and harbour will be located in Kalmar harbour. Attachement A.
- **10.2.** The racing areas will be Kalmarsund.

11. THE COURSE.

Courses will be as per the current IFA Championship Rules. A triangular course will be sailed in winds over 12 knots; under 12 knots, the course will be a windward/leeward race with an offset mark at the top and a gate at the bottom.

12. PENALTY SYSTEM.

12.1. RRS Appendix N will apply.

13. SCORING.

- **13.1.** The low point scoring system of RRS Appendix A will apply, modified so that when four or fewer races have been completed, a boat's series score will be the total of her race scores.
- **13.2.** 4 races are required to be completed to constitute a championship.

14. SUPPORTER BOATS.

Any coaches traveling to this event to coach is responsible for supplying a National Flag for any countries for which they will coach. Such flag(s) must be displayed aboard any coach or support boat while afloat in the vicinity of the racing area. Coaches will have to register and sign the "Coaches Code of Conduct".

15. BERTHING.

Boats shall be kept in thier assigned places in the boatpark.

19. PRIZES.

- **19.1.** The perpetual trophy will be awarded to the winner. The Organizing Authory will provide prizes for the first ten (10) boats overall, the top 3 juniors, and memory picture to all skippers.
- **19.2.** Daily first prizes will be awarded to the skippers finishing first in each race.

20. DISCLAIMER OF LIABILITY.

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority and all parties involved with the organization will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

21 INSURANCE.

Each participating boat shall be insured with valid third party liability insurance with a minimum cover of Euro 1.000.000 shall be in existence for the entire duration of The Finn European Championship. It shall be the sole and inescapable responsibility of the competitor to have such insurance cover and to provide written proof there of to the Organising Authority upon request.

23 MEDIA, IMAGES AND SOUND.

The Organizing Autority shall have the right to use any media, images and sound recorded during the event free of charge.

24 DOPING CONTROL.

The relevant authoritys may carry out doping controls during the event. All participants are obliged to submit themselves to doping control. ISAF Regulation 21 and RRS 5 will apply. The event shall be deemed to start at : 2005-08-06.
