# Notice of Race 30th Palamós-Christmas Race

The 30th Palamós-Christmas Race will be held from December 26 to 30 December 2005, on waters of Palamós Bay (Girona), organised by the CLUB NÁUTICO COSTA BRAVA and CLUB DE VELA PALAMÓS with the collaboration of the REAL FEDERACIÓN ESPAÑOLA DE VELA and FEDERACIÓ CATALANA DE VELA.

#### 1. **RULES**

- 1.1 The event will be governed by:
  - The rules as defined in the ISAF Racing Rules of Sailing (RRS2005-2008)
  - The EUROLYMP Rules.
- 1.2 RRS 44.2 (two turns penalty) will apply. For the Tornado and 49er classes rule 44.2 is changed so that the two turns are replaced by one turn.
- 1.3 RRS 42 will be judged on the water.

#### 2. ADVERTISING

Competitors must comply with ISAF regulation 20.

NEIL PRYDE RS: X sailors may be required to wear a competitor's bib.

Yachts may be required to display advertising under ISAF regulation 20.3 (d)(i).

All Class rules in contradiction with this rule are altered in consequence.

#### 3. CLASSES TO COMPETE

The 30th Palamós - Christmas Race is reserved to the following Classes:

MEN:	470, LASER, NEIL PRYDE RS:X.
WOMEN:	470, LASER RADIAL, NEIL PRYDE RS:X, YNGLING.
OPEN:	FINN, TORNADO, 49ER, STAR.

INVITED CLASS: EUROPE (Open)

#### 4. ELIGIBILITY

Competitors must comply with eligibility requirements established in ISAF regulation 19.

### 6. **REGISTRATION OF COMPETITORS**

- 6.1 Each competitor shall personally register and sign the registration form at the Race Office before 19.00 hrs on 26th December 2005.
- 6.2 Registration is subject to the presentation before that time of the following documents:

- A valid measurement certificate of the boat (except for classes Neil Pryde RS:X, Laser, Laser radial and 49er)

- A valid third-party liability insurance, with a minimum cover of 300.500 euros
- For Spanish competitors only, the RFEV 2005 license.

Courses will, as far as possible, be of the same configuration as those proposed for the 2004 Olympic Regatta.

Notwithstanding the above, the racing format will follow the decisions adopted for EUROLYMP 2005 events.

#### 9. SCORING

The Low-Point Scoring System (RRS Appendix A) will apply.

#### 10. SAIL NUMBERS

LASER boats shall comply with RRS Appendix G1.1 - IDENTIFICATION

#### 11. INTERNATIONAL JURY

An International Jury will be appointed in accordance with RRS Appendix M. Its decisions will be final as provided in rule 70.4

#### 12. DISCLAIMER

All those taking part in the event do so at their own risk and responsibility.

The Organising Committee or any part involved with the organisation of the event disclaim any and every responsibility whatsoever for loss, damage, injury or inconvenience that might occur to persons and goods, both ashore and at sea as a consequence of participation in the races covered by this notice of race and the sailing instructions.

Attention is drawn to the RRS Fundamental Rule 4 - Decision to Race, which states:

"The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

#### 13. **PRIZES**

Prizes will be awarded to the top three competitors in each event.

The "TROPHY MANUEL ALBALAT IN MEMORIAM" will also be awarded.

The trophy will be displayed at the Club office.

Europe class competitors are not eligible for the "Trofeo Manuel Albalat in memoriam".
